**Outdoor Regional Partnerships**

Jody Kennedy, CPW Public Outreach Specialist, and Dan Zimmerer, CPW Partnership Coordinator, provided an update on CPW’s Outdoor Regional Partnership vision. CPW continues to evolve its concept for Outdoor Regional Partnerships that will inform a statewide vision that benefits wildlife and natural resources while balancing Colorado’s incredible recreation opportunities.

**GOCO Finance Update**

Ms. Conrad presented the Finance Update addressing the Year End Financial Statements and Audit, Fiscal Year 2021 operating budget vs. actual and management discussion and analysis, and cash management metrics.

**Pathway to Alternative Investment**

Mr. Tenneson provided a high-level overview of GOCO’s continued research into alternative investment considerations as discussed in previous finance committee and board meetings.

**Spending Plan Amendment**

In June of 2020, the board approved a new 5-year spending plan which included some unknowns and variables that were explicitly identified as “to be determined” items with the expectation it would be amended in December.

Mr. Tenneson proposed those amendments to the five-year spending plan as forwarded from the finance committee and detailed in the presented materials. (See Attachment 2).

December 10, 2020**

**A Resolution Approving an Amendment to the Five-year Spending Plan**

This resolution is made in view of the following facts:

1. Per Article XXVII(6)(2)(e), the board shall determine what portion of moneys allocated to the trust fund shall remain in an interest-bearing account;
2. On March 15, 2018, via Resolution 2018-08, the GOCO Board approved policy 2.8 and 2.10 *Spending Plans and Opportunity for Public Comment and Multiyear and Annual Spending Plans*;
3. On June 11, 2020, via Resolution 2020-16, the GOCO Board approved a five-year spending plan for fiscal years 2021-2025 and acknowledged that outdoor recreation and wildlife purpose funds would be further defined in December 2020 through discussions of the annual Investment Proposal and Colorado Parks & Wildlife ("CPW") participation in the Centennial Program;
4. Since June 2020, GOCO staff has worked closely with CPW and other stakeholders to refine the five-year spending plan; and
5. On November 17, 2020, the committee of the whole board recommended this amendment be forwarded to the GOCO Board for final action.

Accordingly, the board resolves to:

1. Amend the five-year spending plan as presented on the following page and which modifies the following components of the plan:

5. The Board has determined that it is appropriate to amend Policy 2.11.F to better reflect GOCO’s practices.

GOCO staff has worked closely with the City of Lamar to implement their Generation Wild vision yet, there remain significant barriers preventing progress as envisioned in 2015. This memo presents staff's recommendation for a project modification and extension that responds to community need and provides the Generation Wild partnership between The City of Lamar and GOCO with a thoughtful offramp.

**Background**

The City of Lamar was selected as a Generation Wild pilot coalition in 2015. The community was well-positioned to move forward with Generation Wild as they had been working collaboratively as LiveWell Prowers County and on implementing community goals associated with their Colorado Health Foundation Healthy Places grant. This community showed progress in improving the quality of life for its youth and possessed the tools to implement a new, community led design and implementation strategy.

In 2016, after a one-year planning period, The City of Lamar received a \$1.3 million Generation Wild implementation grant. Of that, \$445,000 would be invested in capital projects and remaining funds would be invested in programs, pathways, and capacity.

To date, GOCO has invested \$395,843 to launch the city's vision for programs, pathways and capacity. Staff is currently working with the city to reconcile these funds. The city was also able to make progress on their proposed capital improvement projects including:

- Wheels Skate Park was funded with \$300,000 and completed in December 2018
- Willow Creek Park Playground was funded with \$80,000 and completed November 2019

While capital projects moved on mostly as expected, the coalition experienced unique challenges with program and pathway implementation stemming from the departure of the local LiveWell Coordinator.

Following that loss of leadership, and with extensive support from GOCO, the city worked to embed their program and pathway vision within the school district. While school district leadership and staff were willing to try, it proved overwhelming to add Generation Wild to their already full plates, understandably. The city was also experiencing ongoing staff turnover in their Generation Wild coordinator position.

City staff has done their very best to bridge community and city council over alignment on the Generation Wild vision and to lead the coalition in the absence of a community-based leader.

When GOCO released the opportunity for coalitions to apply for strategic planning funds in October 2019, the City of Lamar elected not to participate in the effort and therefore, did not apply for continued Generation Wild funding.

Through our partnership with the City of Lamar and through the city's steadfast participation in the Generation Wild network, we have had opportunities to learn and reflect on how the Generation Wild process and framework may have created barriers and challenges to success for this rural community. GOCO anticipated challenges within the Generation Wild framework; all coalitions have experienced them in their own way. However, the challenges with the City of Lamar's program and pathways vision have, understandably, proven too big to overcome. There are many successes from our Generation Wild investment in the City of Lamar and, moving forward, we look forward to continued partnership with the city through other GOCO grant opportunities.

### **Modification Request**

GOCO staff has worked collaboratively with the City of Lamar over the years, offering flexibility and providing assistance and resources to support their success in Generation Wild. Together, we've done the best we can and, at this stage, are forwarding this modification and extension request as the next right step.

The City of Lamar is requesting a modification to their Generation Wild vision to redirect \$524,127 in remaining funding from places, programs, pathways, capacity to solely capital improvements prioritized in the city's 2015 master plan (QUESTION – is this a community-led master plan?). Projects include:

- Addition of a picnic and camping area at North Gateway Park. This investment will expand on the \$65,000 awarded as part of the original 2016 vision;

- Adding a new playground structure at the Lamar Sports Complex, which is a central, community gathering place;
- Expand the soccer field and lighting at Escondido Park; and,
- Tennis court resurfacing.

### **Recommendation**

Staff recommends that the board approve the City of Lamar's modification request to reallocate the remaining \$524,157 in funding to complete the capital projects as identified in this memo and the attached budget.

Staff also recommends that the board extend the City of Lamar's project to June 30, 2022 to provide the city time to complete the capital projects as proposed. If the project is not completed by this deadline, funds allocated to it may be automatically deauthorized with no further action by the board being necessary.

It is staff's opinion that this modification is the best opportunity for GOCO to ensure that our investments in this community is accessible for its citizens and by provides amenities of value to them.

**A Resolution Concerning a Discretionary Investment in the Youth Corps Initiative**

This Resolution is made in view of the following facts:

1. The board established the Youth Corps Initiative in 2011 to support projects that employ young adults on projects that further GOCO's constitutional mission. The purpose of the funding partnership was to both complete conservation service projects of interest to GOCO and provide employment, training, and education opportunities to youth and young adults in Colorado.
2. GOCO Board Policy 2.11(E) establishes that, through its discretionary authority, the board may "make other expenditures which it considers necessary and proper to the accomplishments of the purposes of" Article XXVII.
3. GOCO does not currently recognize Colorado Youth Corps Association (CYCA) as an entity eligible to receive GOCO funding under any funding category.
4. The board allocated \$1,000,000 for the Youth Corps Initiative in its FY 21 spending plan.
5. CYCA is a statewide coalition of 8 youth conservation corps that employ and train youth and young adults on land, water, and energy conservation projects. Youth corps are a proven strategy for engaging young people in service to their communities and stewardship of their environment. CYCA oversees a comprehensive accreditation process and has extensive experience administering grants. As a result, CYCA represents the partner organization most capable of administering the Youth Corps Initiative on behalf of GOCO.
6. GOCO and CYCA jointly reviewed 71 proposals and recommended that board fund 27 of them.

Accordingly, the board RESOLVES to:

1. To exercise its discretionary authority and invest \$1,000,000 to the projects identified in the attached "Youth Corps List of Projects Recommended for Funding," allocating \$500,000 from the local government purpose and \$500,000 from the open space purpose.
2. To allocate \$60,000 of the total as a direct expenditure to CYCA made retroactive to August 1, to reimburse CYCA for administrative costs associated with the application process for the FY 21 cycle.

3. Authorize GOCO to make payment directly to CYCA based upon each applicant's authorization to do so.
4. Authorize the executive director to make minor adjustments in recommended funding levels if a project cannot proceed as anticipated. In the event significant funding changes are necessary as these projects progress, the executive director will consult with the board for further direction.

Consistent with the board's procedure on overdue grants, staff sent reminder notices to grantees with approaching due dates. Subsequent communications with grantees led staff to make the following recommendations.

### Local Parks and Outdoor Recreation Grant

#### **#17054 Westminster Station Park - Phase 1 – \$350,000.00**

On March 23, 2017, the board awarded \$350,000.00 in local government purpose funds to the City of Westminster to construct Phase I of Station Park, an eventual 33-acre park adjacent to the newly opened Westminster Station along the RTD B-Line with connections to the Little Dry Creek Trail. The original completion date for the project was March 23, 2019. The city received a staff and board extension through December 31, 2020 as there were delays in fundraising, land acquisition from the county, and final design work. While stalled by COVID-19, construction began in October 2020 and is set to be completed by fall 2021. As such, the City of Westminster is requesting a board extension through December 9, 2021 to complete the project and submit final reporting.

Recommendation: Approval of extension request with the following conditions:

- Complete the project and submit the final report to GOCO by December 9, 2021.
- If the project is not closed by its extension date deadline, funds allocated to it may be automatically deauthorized with no further action by the board being necessary.

### Generation Wild Grant

#### **#17886 SLV Inspire / Town of Antonito – \$221,873.76**

On December 8, 2016, the board awarded \$1 million in local government purpose funds to the Towns of Antonito and Saguache, the City of Creede, and Mineral County to work as a coalition to address the unique challenges young people face in the San Luis Valley connecting with nature and getting outside. The original completion date for the project was June 30, 2020. While the SLV Inspire vision is progressing, the Town of Antonito's capital development project is taking longer than expected.



Of the \$1 million SLV Inspire grant, the Town of Antonito in partnership with Conejos Clean Water received \$421,874.00 to administer both programming and capital development projects. Specifically, \$221,873.76 was awarded to construct an outdoor education center and other site amenities to serve as a year-round outfitting hub and much needed venue to host educational classes and local meetings. Staff awarded an extension to the town through December 10, 2020 due to delays with contracting, land acquisition, and final design documents. Construction did not begin until fall 2019. To-date construction is still underway with many of the outdoor site amenities complete. Project completion is expected by summer 2021. As such, the Town of Antonito is requesting a board extension through September 23, 2021 to complete the project and submit final reporting.

Recommendation: Approval of extension request with the following conditions:

- Complete the project and submit the final report to GOCO by September 23, 2021.
- If the project is not closed by its extension date deadline, funds allocated to it may be automatically deauthorized with no further action by the board being necessary.

### **Open Space Grants**

#### **#18107 Arkansas River and Riparian Protection – \$505,500.00**

On December 15, 2017, the board awarded \$505,500 in open space purpose funds to the Central Colorado Conservancy (CCC / Conservancy) to purchase eight properties owned by the Andrik family totaling 90 acres along the Arkansas River between Leadville and Granite. The plan is to open the properties for public fishing access to be jointly managed with the Arkansas Headwaters Recreation Area. The acquisitions will expand CCC's existing Arkansas River Preserve and continue to maintain habitat for bighorn sheep, elk, mule deer, bobcat, mountain lion, and various bird species. The properties follow the Top of the Rockies National Scenic Byway, the Collegiate Peaks Scenic Byway and the future Stage and Rail Trail.

The original project completion date was December 15, 2019. CCC received a staff extension through June 30, 2020 and a board extension through December 31, 2020. While the project has experienced a significant number of setbacks, hurdles, and challenges, CCC is making significant progress toward bringing this exceptional conservation and public access project to completion. The previous staff and board extensions were critical and provided CCC the necessary time to work through issues with replacing matching funds, due diligence reporting requirements, and a death in the Andrick family. While CCC's goal was to close the transaction by the end of the year, they are requesting additional time to finalize the public access easement with Colorado Parks and Wildlife and receive the necessary CPW approvals.

The project will be presented to the CPW Wildlife Commission in mid-November and then to the State's Capital Development Committee in early December. CCC explained that it took longer than expected to get the state's approval of the public access easement because there



were several court decrees and historical surveys that were needed to demonstrate public access points on the property. The project has since received the necessary approvals from the CPW Real Estate Team and the AG and DNR Director have demonstrated support for funding the project.

The plan is to close on the property acquisitions, conservation easement, and access easements at one closing during the first part of the year, either January or February 2021. The landowner has agreed to extend the purchase contract through April 1, 2021.

Recommendation: Approval of extension request with the following conditions:

- Completion of the Arkansas River and Riparian Protection transaction by April 1, 2021, the purchase contract deadline.
- If the project is not closed by its extension date deadline, funds allocated to it may be automatically deauthorized with no further action by the board being necessary.

#### **#18660 – Sandstone Ranch Open Space - \$3,500,000.00**

On June 14, 2018, the board awarded Douglas County, through the Protect Initiative, \$3,500,000 in open space purpose funds to purchase the 2,038-acre Sandstone Ranch near Larkspur, CO to provide public open space. GOCO's funds will be used to reimburse the county for part of the \$18M purchase price. The project was ranked number one in the grant cycle and identified as a once in a life-time opportunity. The property shares a 3.5-mile border with the Pike National Forest and is easily accessible from I-25. Natural habitat on the property includes riparian and wetland areas along Gove and West Plum Creeks, hay meadows, shrublands, and steep forested slopes. These habitats provide food, shelter, breeding ground, and migration corridors for many wildlife species including but not limited to black bear, mountain lion, elk, mule deer, and coyote. The property also provides critical habitat for the Preble's meadow jumping mouse, a species listed as threatened under the Endangered Species Act. Recently opened to the public, the County is developing soft-surface non-motorized trails for the public in an area of the County with limited public trails. Low impact uses of the property will include hiking, biking, equestrian, wildlife viewing, photography and other passive recreational activities along with nature based public educational opportunities.

The original project completion date was June 14, 2020. The county received a staff extension through December 14, 2020 to address delays associated with the COVID-19 pandemic and so the county could negotiate a purchase contract agreement, Declaration of Restrictions, and Mitigation Property Management Plan with the Chatfield Reservoir Mitigation Company. The purchase of the property was possible in part because a portion of the property is being protected to provide mitigation credits for expansion of the Chatfield Reservoir. The county will receive \$6M for this part of the transaction. Work on the conservation easement could not be completed until the agreements and management plan were finalized and approved by the U.S. Army Corps of Engineers. The necessary Army Corps approvals have been obtained and the



conservation easement due diligence documents have been submitted to GOCO. Upon submittal to GOCO, it was discovered that there are a few outstanding due diligence items that need to be addressed that will require additional time past the staff extension. In addition to completing GOCO's due diligence requirements, the conservation easement will need to be approved by the Douglas County Board of County Commissioners and Douglas Land Conservancy. To finish these few remaining transactional requirements, the county is requesting a board extension through June of 2021. It is very likely that the project will close well before this deadline. The county's goal is to close in the first quarter of 2021.

Recommendation: Approval of extension request with the following conditions:

- Completion of the Sandstone Ranch Open Space transaction by June 30, 2021
- If for any reason the project encounters any additional unforeseen delays, staff and the County would like to reserve the opportunity to seek a second board extension.
